4) First aid measures

General information

By continuous complaints consult a physician.
Remove immediately contaminated clothing and shoes and launder thoroughly before reusing.

After inhalation

Remove affected person from danger area.
Ensure supply of fresh air.

After skin contact

Wash off immediately with soap and water.

After eye contact

Separate eyelids, wash the eyes thoroughly with water (15 min.)
Eye treatment by an Occulist.

After ingestion

Summon a doctor immediately.
Never give anything by mouth to an unconscious person.
If individual is drowsy or unconscious place in recovery position (on left side, with head down).
Rinse out mouth and give plenty of water to drink.

5) Fire-fighting measures

Suitable extinguishing media

Foam
Dry powder

Extinguishing media that must not be used for safety reasons

Full water jet

Special exposure hazards arising from the substance or preparation itself, its combustion products or from resulting gases

6) Accidental release measures

Personal precautions

Environmental precautions

Do not discharge into the drains/surface waters/groundwater.

Methods for cleaning up/taking up

Take up with absorbent material (eg sand, kieselguhr, universal binder).
Send in suitable containers for recovery or disposal.

7) Handling and storage

Handling

Advice on safe handling

Provide good ventilation of working area (local exhaust ventilation if necessary).
If workplace limits are exceeded, a respiration protection approved for this particular job must be worn.

Advice on protection against fire and explosion

Vapours can form an explosive mixture with air.
Take precautionary measures against static charges.
Keep away from sources of heat and ignition.
Use explosion-proof equipment/fittings and non-sparking tools.

Storage

Requirements for storage rooms and vessels

Containers which are opened must be carefully resealed and kept upright to prevent leakage.
Always keep in containers of same material as the original one.
